Reduction of Landslide Vulnerability by Mitigation Measures Project

VACANCIES

Applications are invited from Sri Lankan citizens for the position of Geotechnical Engineer at the Project Management Unit (PMU) of the Reduction of Landslide Vulnerability by Mitigation Measures Project (RLVMMP). This project is funded by the Asian Infrastructure Investment Bank (AIIB) and the Government of Sri Lanka (GoSL), with a project value of US\$ 101.3 million. The Ministry of Defence serves as the executing agency, while the National Building Research Organisation (NBRO), operating under the Ministry of Defence, is the implementing agency. The project aims to mitigate landslide risks at 163 identified locations across the districts of Badulla, Kandy, Matale, Kegalle, Ratnapura, Nuwara Eliya, Kalutara, Colombo, Matara, and Kurunegala, as well as unstable areas along railway tracks. Phase I successfully mitigated critical landslide-prone sites, and Phase II is now addressing the remaining sites.

1. Geotechnical Engineer (01 Position - PS4 level – Category C)

Position Summary, Minimum Qualifications and Experience:

He/she shall be responsible for assisting Senior Geotechnical Engineer and senior staff for reviewing and managing overall Design & Construction works of slope rectification measures under phase II of this Project.

1. A successfully completed Bachelor's Degree in the Civil Engineering or equivalent field which is recognized by the University Grants Commission **or**

A qualification recognized by the University Grants Commission as an equivalent qualification to the degree in the field of Civil Engineering **or**

An associate membership/ similar professional qualification obtained from a recognized professional institution in the Civil Engineering field **With**

At least 03 years post qualifying experience in the Construction /Geotechnical Engineering field works.

2. IT Specialist (01 Position - PS 5 Level)

Position Summary Minimum Qualifications and Experience:

Responsible for providing comprehensive IT support to the project, including maintaining the project website, preparing presentations and documentation, delivering technical support, and managing software installations and upgrades.

A qualification recognized by the University Grants Commission as an equivalent qualification to the degree in the relevant field **or**

An associate membership/ a similar professional qualification obtained from a recognized professional institution in the relevant field **or**

Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 7, Issued by a Technical Vocational Training Institute Accepted by Tertiary and Vocational Education Commission for a post related to the relevant field

and

at least 05 years of experience in the IT Field.

- 2) Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 6 issued by a Technical vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to the relevant field.

and

at least 10 years of experience in the IT Field.

- 3) Having Obtained a certificate of proficiency not below than the National Vocational Qualification Level 5 is-sued by a Technical Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to the relevant field.

and

at least 15 years of experience in the IT Field.

Candidates who meet any one of the criteria listed in 1,2 or 3 will be eligible to apply.

General Conditions

- The recruitments will be initially for one year on a contract basis, and renewable thereafter annually subject to satisfactory performance.
- Salaries and other conditions for the positions will be as per Management Services Circular No 01/2019
- EPF and ETF contribution by employer is 12% and 3% and the contribution for EPF by the employee is 8% of the monthly salary.
- Age limit should be below 64 at the date of closing applications.
